General Administration – Bye Election to Kerala Legislative Assembly 2012 – Day of Poll – Declaration of holiday on 17<sup>th</sup> March 2012 to the Public Offices and other Institutions in the area covered by Piravom Legislative Assembly Constituency - Orders issued.

**ORDER**

Government are pleased to declare Saturday, the 17<sup>th</sup> March 2012 as a public holiday for all public offices and educational institutions and a paid holiday for all Government/quasi-Government and Commercial establishments in the area covered by Piravom Legislative Assembly in connection, with the Bye Election to the Piravom Legislative Assembly Constituency.

The Labour Commissioner will make necessary arrangements with all Private Enterprises, Private Industrial Centres and other Private Institutions under the Shops and Commercial Establishment Act, and located on the aforesaid areas to declare the day of poll viz: the 17<sup>th</sup> March 2012 as a paid holiday for all their employees. No deduction or abatement of the wages of any such persons shall be made on account of a holiday having been granted in accordance with law and if such person is employed on the basis that he would not accordingly receive wages for such a day, he shall nonetheless be paid for such a day, the wages he would have drawn had not a holiday been granted to him on that day.

Employees including casual workers who are ordinarily resident of the above constituency where poll is taking place, and registered as an elector, in that constituency but serving/employed in an industrial undertaking or an establishment located outside the constituency where he/she is resident have to be given the benefit of paid holiday on the day of poll.
