ORDER

The Election (General) Department, as per the reference read above, has requested to declare 'Dry Days' through out the areas in an around 140-Neyyattinkara Legislative Assembly Constituency, for a period from 5.00 P.M. on 31.5.2012 to 5.00 P.M. on 2.6.2012, and the whole day on 15.6.2012 (i.e., the day of counting), for the peaceful and smooth conduct of free and fair poll of the Bye-Election, under section 135 C of the Representation of the Peoples Act, 1951.

- 2. Government are, therefore, pleased to order that the days from 31.5.2012 (5.00 P.M.) to 2.6.2012 (5.00 P.M.) and the whole day on 15.6.2012, the day of counting of votes, will be 'Dry Days' for all the liquor shops, within the polling areas of 140-Neyyattinkara Legislative Assembly Constituency, for the peaceful and smooth conduct of free and fair poll of the Bye-Election.
- 3. During the 'Dry Days', no spirituous, fermented or intoxicating liquors or other substances of a like nature shall be sold, given or distributed at a hotel, eating house, tavern, shop or any other public place or private within the said polling areas. All liquor shops, hotels, restaurants, clubs and other establishments selling/serving liquor will remain closed, and are not permitted to serve liquor on these days. The storage of liquor by individuals is also prohibited.

4. The Excise Commissioner will issue necessary instructions to the officials concerned, to take necessary precautionary measures, vigorously, to detect and prevent storage and sale of liquor by unlicensed persons, and in unlicensed premises during the above said days.
