**ORDER**

The poll in connection with the Bye-election to 06-Malappuram Lok Sabha Constituency will be held on 12<sup>th</sup> April 2017 (Wednesday). Government are pleased to declare the day of Poll i.e. the 12<sup>th</sup> April 2017 (Wednesday) as public holiday for all Public Offices and Educational Institutions and it is further declared that the day of poll will be a paid holiday for all Government/Quasi Government and Commercial Establishments under the Negotiable Instruments Act, 1881 for the area covered by the Constituency.

Employees including casual workers who are ordinarily resident of the above Constituency where poll is taking place, and registered as an elector, in that constituency but serving/employed in an industrial undertaking or an establishment located outside the constituency where he/she is resident will be eligible for the benefit of paid holiday on the day of poll.
