ORDER

The poll in connection with the Bye-election to 041-Vengara Legislative Assembly Constituency will be held on 11th October, 2017 (Wednesday). Hence Government are pleased to declare the day of Poll i.e. the 11th October, 2017 (Wednesday) as public holiday for all Public Offices and Educational Institutions and a paid holiday for all Government/Quasi Government and Commercial Establishments in the area covered by the Constituency in connection with the Bye-election to the 041-Vengara Legislative Assembly Constituency.

In addition to the above, Government are pleased to declare the following:

The Labour Commissioner will make necessary arrangements with all Private Enterprises, Private Industrial Centres and other Private Institutions under the Shops and Commercial Establishment Act, and located on the aforesaid areas, to declare the day of poll viz., the 11th October, 2017 (Wednesday) as a paid holiday for all their employees. No deduction or abatement of the wages of any such persons shall be made on account of a holiday having been granted in accordance with law and if such person is employed on the basis that he would not accordingly receive wages for such a day, he shall nonetheless be paid for such a day, the wages he would have drawn had not a holiday been granted to him on that day.

Employees including casual workers who are ordinarily resident of the above Constituency where poll is taking place, and registered as an elector, in that constituency but serving/employed in an industrial undertaking or an establishment located outside the constituency where he/she is resident have to be given the benefit of paid holiday on the day of poll.
