ORDER

In view of the General Election to the Kerala Legislative Assembly Constituencies – 2011 proposed to be held on 13.04.2011, the Government are pleased to fix the hire charges of Light and Heavy (private) vehicles engaged for election duty as follows:

Class	Daily (24 hrs) Rs.	Rs./Hour	Daily distance limit	Excess charge / KM
Buses : Seating capacity of not less than 30 person (Excluding driver and conductor)	4000/-	Rs.180/Hr and part thereof in excess of 24 hrs subject to a maximum of Rs.4000/- per day	200 KM	Rs.25/KM
Mini Buses: Seating capacity of less than 30 person (Excluding driver and conductor)	3000/-	Rs.180/Hr and part thereof in excess of 24 hrs subject to a maximum of Rs.3000/- per day	200 KM	Rs.14/KM

Category of contract carriages	Rate of hire charges	Detention charge
Motors cabs (tourist motor cabs and ordinary motor cabs with a seating capacity of not more than 7 persons including driver) Cars & Jeeps, Maruti Van / permitted vans.	Rs.8/- per KM subject to a minimum of Rs.60/- for a distance upto 3KM. In the case of air conditioned motor cabs, 10% of the hire charges may be charged additionally.	Rs.25/- per hour subject to a maximum of Rs.300/- per day.

The rates of the hire charges sanctioned above are inclusive of all charges like cost of petrol / diesel etc. Pay and Bata to crew will have to be met by the owners themselves.

The expenditure on this will be met from the fund allotted from the "8000 Contingency Fund", the final adjustment of which will be made to "2015-00-106-99-34 OC (NP)".
