The Returning Officers may be directed to allot the common symbol mentioned above to the candidates set up by the aforesaid registered un-recognised political party, subject to fulfillment of the provisions of Para 13 of the Election Symbols (Reservation and Allotment) Order, 1968 relating to setting up of candidates by the parties. It may also be noted that said common symbol allotted to the candidates of the above mentioned political party, is not allotted by oversight to any other candidates in these constituencies. However, the said symbol shall be

available for allotment as free symbol to other candidates in the constituencies where the aforesaid parties do not actually set up their candidates.

3. In the event of the above said party failing to meet the requirement of the minimum number of candidates, as prescribed in Para 10B of the said Symbols Order, 1968, i.e., 5% of total number of <u>Assembly Constituencies</u> in the concerned State in case of Assembly election, then the said common symbol shall not be available to their candidates.
