No.318/CS-KL/2012 (1):- Whereas, the President of India has, by notification issued under section 12 of the Representation of the People Act, 1951 (43 of 1951) and published in the Gazette of India on 8<sup>th</sup> June, 2012, been pleased to call upon the elected members of the Legislative Assembly of the State of Kerala to elect three members to the Council of States;


Now, therefore, in pursuance of sub-section (1) of section 39 and section 56 of the said Act, the Election Commission of India hereby –

(A) appoints, with respect to the said election-

- (a) the 15<sup>th</sup> June, 2012 (Friday), as the last date for making nominations;
  - (b) the 16<sup>th</sup> June, 2012 (Saturday), as the date for the scrutiny of the nominations;
  - (c) the 18<sup>th</sup> June, 2012 (Monday), as the last date for the withdrawal of candidatures;
  - (d) the 25<sup>th</sup> June, 2012 (Monday), as the date on which a poll shall, if necessary, be taken; and
  - (e) the 27<sup>th</sup> June, 2012 (Wednesday), as the date before which the election shall be completed;
- and

(B) fixes the hours from 9:00 A.M. to 4:00 P.M., as the hours during which the poll shall, if necessary, be taken on the date specified above for the election.


